



Applicants Selected for FY 2023 Brownfields Multipurpose, Assessment, Revolving Loan Fund, Cleanup Grants and RLF Supplemental Funding

Today we are announcing that 262 communities were selected to receive 267 grant awards for a total of \$215 million in Brownfields Multipurpose, Assessment, Revolving Loan Fund, and Cleanup (MARC) Grant funding. The Brownfields Grant funding announced today will help communities remove longstanding barriers to reuse and spur new redevelopment to transform communities into sustainable and environmentally just places. These Brownfields Grants not only support economic growth and job creation, but they also empower communities to address the environmental, public health, and social issues associated with contaminated land.

WASHINGTON (May 11, 2021) — Today, the U.S. Environmental Protection Agency (EPA) is announcing the selection of 151 communities to receive 154 grant awards totaling \$66.5 million in Brownfields funding through its Multipurpose, Assessment, and Cleanup (MAC) Grants.

This funding will support underserved and economically disadvantaged communities across the country in assessing and cleaning up contaminated and abandoned industrial and commercial properties. Approximately 50 percent of selected recipients will be receiving EPA Brownfields Grant funding for the first time and more than 85 percent are located in or serving small communities.

“Through our Brownfields Program, EPA is delivering on the Biden Administration’s commitment to lifting up and protecting overburdened communities across America, especially communities that have experienced long periods of disinvestment and decay,” **said EPA Administrator Michael S. Regan**. “These assessment and cleanup grants will not only support economic growth and job creation, but they will also empower communities to address the environmental, public health, and social issues associated with contaminated land.”

Today’s grant announcement includes:

- \$8.8 million for 11 Multipurpose Grants, which will provide funding to conduct a range of eligible assessment and cleanup activities at one or more brownfield sites in a target area.

WASHINGTON—Today, U.S. Environmental Protection Agency (EPA) Administrator Andrew Wheeler, joined by the White House Executive Director for the Opportunity and Revitalization Council Scott Turner, traveled to Dauphin County, Pennsylvania, to announce that 149 communities have been selected to receive 151 grant awards totaling \$64,623,553 million in EPA Brownfields funding through the Multipurpose, Assessment, and Cleanup (MAC) Grant Programs. These funds will aid under-served and economically disadvantaged communities in Opportunity Zones and other parts of the country in assessing and cleaning up abandoned industrial and commercial properties. Forty percent of the communities selected for funding will receive assistance for the first time. Dauphin County was awarded \$300,000 in grant funding.
