**WASHINGTON** - The U.S. Department of Housing and Urban Development (HUD) today announced awards totaling \$150.9 million for new affordable and innovative housing investments in Tribal communities. Principal Deputy Assistant Secretary Richard Monocchio made the announcement today in Anchorage, Alaska, where he presented \$6 million to the Cook Inlet Housing Authority to build 51 new housing units to increase the number of homes available to low-income Alaskan Native families.

## HUD Announces \$128 Million to Tribal Communities for Construction of New Affordable Housing

*August 30, 2023*

**WASHINGTON** - Today, the U.S. Department of Housing and Urban Development (HUD) announced 22 awards totaling approximately \$128 million for affordable housing investments in Tribal communities. HUD Secretary Marcia L. Fudge made the announcement today in Kenai, Alaska, where she presented \$7.5 million to the Kenaitze-Salamatof to build 18 new housing units to increase the number of homes available to low-income Alaskan Native families.

The Indian Housing Block Grant Competitive (IHBG) funds play a crucial role in bolstering vibrant American Indian and Alaska Native communities. These funds are designated for various purposes, such as new construction, rehabilitation, and infrastructure to support affordable housing within Indian reservations and similar areas. The IHBG Competitive program holds particular significance for Tribal communities as it injects essential financial resources that aid in establishing new affordable housing options for disadvantaged Tribal families. Today, in furtherance of the Federal Government's trust responsibility, HUD makes another investment in Tribal communities by awarding \$128 million to 22 communities through the Competitive Program. ### **HUD Announces \$147 Million to Tribal Communities for Affordable Housing and Community Development**

WASHINGTON – The U.S. Department of Housing and Urban Development (HUD) on Thursday announced 83 awards totaling \$147 million for affordable housing and community development projects that primarily benefit people with low and moderate incomes in American Indian and Alaska Native communities.

“Every person deserves a fair shot to get ahead—one that includes access to safe, affordable housing and a vibrant community,” said **Secretary Marcia L. Fudge**. “That is why we are pleased to make over 80 awards to American Indian and Alaska Native communities across the country so that they can build new housing and solve their most pressing housing and economic challenges. These funds are an important investment in Tribal communities that need it most.”

HUD awarded \$95 million to 24 communities through the Indian Housing Block Grant (IHBG) Competitive Program to help Tribes develop affordable housing. Grant funds may be used for new construction, rehabilitation, and infrastructure to support affordable housing on Indian reservations and in other Indian areas. [View the list of awardees here.](#)

## **HUD Awards More Than \$90 Million for Affordable Housing in Tribal Communities**

*24 Tribes receive funds that will support the construction of approximately 350 new housing units.*

WASHINGTON - The U.S. Department of Housing and Urban Development today announced over \$90 million in grant awards to 24 Tribes and Tribally Designated Housing Entities (TDHEs) across the country to support new housing construction, housing rehabilitation, and critical infrastructure projects.

“This past year was a stark reminder of just how important access to safe, stable housing is—especially in Tribal communities disproportionately impacted by the COVID-19 pandemic,” said Secretary Marcia L. Fudge. “The funding HUD is awarding today will support much needed affordable housing investments in Indian Country.”

The funds were awarded through HUD’s Indian Housing Block Grant (IHBG) Competitive program to help construct new housing units for low-income families living in Tribal communities. It is projected that this funding will support the construction of approximately 350 new housing units, which will help spur economic opportunities in these communities. This year’s IHBG competition generated a lot of interest and was very oversubscribed with a total of 141 applicants submitted by Tribes and TDHEs. This is the second time HUD is making awards under this program; the first round of awards was made in [December 2019](#).

**HUD AWARDS NEARLY \$200 MILLION FOR AFFORDABLE HOUSING IN NATIVE AMERICAN COMMUNITIES**

***Funds will help construct approximately 1,200 new housing units***

WASHINGTON - The U.S. Department of Housing and Urban Development yesterday announced nearly \$200 million in grant awards to 52 Native American Tribes and Tribally Designated Housing Entities (TDHEs) across the Nation for new housing construction, housing rehabilitation, and critical infrastructure projects. HUD announced the grants during the 2019 National American Indian Housing Council (NAIHC) Legal Symposium in Las Vegas.

"HUD is excited for this new opportunity to better serve Native American communities through our government-to-government relationship with the Tribes," said HUD Secretary Ben Carson. "I look forward to seeing the new housing units and renovations the Tribes will complete with this much needed investment in affordable housing."

These grants will be awarded through HUD's Indian Housing Block Grant (IHBG) program to help construct approximately 1,200 new housing units for low-income families living on Indian reservations or in other Indian areas, and spur economic opportunities in distressed communities to help our neediest families. Additionally, our Tribal partners are maximizing this investment by leveraging an estimated \$90 million dollars in additional resources. Many of the grantees announced today are located in Opportunity Zones. Created under the 2017 Tax Cuts and Jobs Act, Opportunity Zones aim to stimulate long-term investments in low-income communities.

"HUD is committed to working collaboratively to address housing needs with our Native American partners," said HUD Assistant Secretary Hunter Kurtz. "The IHBG program is a wonderful example of how HUD continues to invest in Tribal communities."

The IHBG competition was extremely competitive. HUD received almost 200 applications from eligible Native American Tribes and TDHEs. Today's awards are the result of a thoughtful and rigorous application process. The following 52 Tribes and TDHEs received grants:
