This funding request is for Year 1 and 2 funds.

The South Carolina Forestry Commission (SCFC) currently has a temporary bridge program. The program has two facets: rental and cost-share. The SCFC has been operating the bridge loan program for 16 months, and it has been well received by the forest industry. The bridges have been used to access approximately 2,960 acres of timberland and have helped to avoid temporary culvert and debris crossings, which have a much higher risk of water quality impact then temporary bridge crossings do. With this funding two more bridges will be added to the rental program, which will allow access to loggers in more areas of the state and reduce wait times.

The cost-share program uses state funds to help defray the purchase costs of temporary bridges for logging. The pre-application period garnered 80 applicants, and unfortunately, the funding allotted was only enough to fully fund eight of those applications. This funding will be used to help additional contractors purchase temporary bridges.

Input Program Information in this Form Field

A portion of the requested funds, \$47,000, will be used to expand the Commission's existing bridge rental program. Two additional bridges will be purchased and located in areas of the state that are not being served by the current program. One bridge will be a three-section 4' x 30' bridge, and the second will be a two-section 6' x 30' bridge. Both will be constructed of steel. Bridges will be rented out using the existing procedure. A lawyer drafted rental agreement will be signed using DocuSign. This agreement has already been drafted and has been in use for over a year. The location of use will be reported by the renter, and basic information (such as stream type and acres accessed) will be gathered at the time of rental. The crossing installation will be inspected at least once during the rental period, and the bridge condition will be inspected upon return. Renters will be charged a rental fee of \$50 per week. The rental fees will be reserved and used as needed for bridge maintenance, repair and replacement. The user is responsible for repairing or replacing the bridges if major damage occurs during the rental period. The bridges will be stored at Forestry Commission office locations. Equipment suitable for loading and unloading the bridges is already in place at chosen locations. All bridges will be inventoried as a part of the SCFC's annual fixed asset inventory process.

Watford Industries (Kingstree, SC) - current pricing for **6'x30' bridge set \$**(b) (4). Purchased bridges from them two years ago for the current bridge rental program.

Andrews Metal Works (Andrews, SC) - current pricing for 6'x30' bridge set \$(b) (4)

John Woodie Enterprises, Inc. (Statesville, NC) - current pricing for **4'x30' bridge set \$(b) (4)**. Purchased bridges from them two years ago for the current bridge rental program.

Local welder that is currently building two sets for loggers funded through the existing cost-share program (Union, SC) - current pricing for 4'x30' bridge set 5(b)(4).

A small portion of the requested funds, \$1,650.00, will be used to purchase chains and binder straps to secure bridges during transport. A quote is attached to this request.

The remaining requested funds of \$301,350.00 will be used to augment the Commission's BMP cost-share program. Funds will be used to improve stream crossing BMP compliance by offsetting a portion of the costs associated with the installation of BMP-compliant stream crossings. Reimbursement payments will be available to qualified forest product operators to purchase temporary bridges. The Forestry Commission will receive applications, provide BMP recommendations where applicable, validate costs and process cost-share payments. This program will follow the procedure that is in place for the existing cost-share program. Application forms, work completed forms, tracking forms and spreadsheets are already established and can be modified to capture additional information if required for this program. Bridge use will be tracked and reported to adequately meet the requirements of this program. Cost-share funds will reimburse forest products operators up to 80% of the actual cost to purchase or manufacture temporary bridges up to a \$16,000 maximum.

There are currently 72 qualified forest products operators on a waiting list for cost-share to purchase temporary bridges from the first application period of the existing program. If the SCFC is approved for funding through this program and can announce another application period, it is anticipated that additional contractors will apply for funds, which will result in a robust potential user list. If, for unanticipated circumstances, there are not enough applicants to use the full funding amount requested for cost-share, the Commission requests that those funds may be used to purchase additional bridges for the SCFC bridge rental program.

- The press release will also be shared with all of the primary forest products manufacturing facilities in the state who will in turn share it with their suppliers.

- An information segment on the program will also be included in the continuing education video that all South Carolina TOP trained loggers, wood buyers, and foresters are required to watch every year.

Forestry and logging are vital to rural South Carolina communities. The majority of working forests and timber harvesting occurs in these rural, underserved areas of the state, and many of the qualified forestry operators meet the definition of underserved as defined by EO 13985. This program will support these underserved business owners by providing a funding opportunity that will enhance the capabilities and quality of their business.

Historically, stream crossings have the lowest BMP compliance rates in SC BMP implementation monitoring studies and continue to be the area with the greatest opportunity for improvement. Stream crossings are critical for water quality protection since they often involve use of heavy equipment and soil disturbance in and near water bodies. Scientific studies have shown that stream crossings constructed below BMP standards produce 2.8 times more erosion and 11.6 times more sediment than ones constructed in compliance with BMPs (1). A cost-share program will encourage BMP compliance by assisting contractors in offsetting the high cost associated with purchasing temporary bridges and installing BMP-compliant stream crossings, thereby reducing the opportunity for water quality impact.

Reimbursement amount will vary based on the actual purchase price of bridges. If all applicants request the maximum allowable amount (\$16,000), \$301,350 will fully fund the purchase of eighteen bridges and partially fund one additional bridge. Additional applicants will be funded if requested reimbursement amounts do not reach the maximum.

If there are not enough applicants to consume the requested amount of cost-share money these funds will be used to purchase additional bridges for the SCFC bridge loan program.
